## WHAT DOES IT COST?

The scheme is free for the Employer to offer to employees.

The employee pays a monthly cost for the vehicle on a lease basis and the payment for this comes directly from the employee's salary. The employee and employer save on the National Insurance costs on the amount deducted. The employee can also save up to 42% on the cost of a new vehicle. Additionally, as insurance, road tax, servicing, and breakdown are also included in the monthly costs, the employee only needs to cover the cost of fuel for the vehicle on top of this.



## HOW DOES IT WORK?

1. Organisation signs up to the scheme.
2. Employees choose their preferred vehicle.
3. Vehicle ordering, delivery, servicing, and collection is arranged for employees.
4. Deductions are taken from an employee's salary over a 2 or 3 year period.
5. The vehicle is returned at the end of the lease.

N.B – Benefit in kind taxation applies to lease vehicles; however, the savings employees can make may outweigh these costs.
